SUMMARY

Now in my 18th year at the Victorian Bar, I have developed a broad commercial and civil advocacy practice, including work in disputed contracts, enforcement of securities, personal and corporate insolvency and product liability. I regularly advise on and negotiate commercial settlements on behalf of clients, whether through structured mediation or Court-ordered ADR processes, or more "informal" channels. I draw on not only my experience as a solicitor and barrister, but on my training as Nationally Accredited Mediator.

As part of my general commercial practice, I work extensively in the highly specialised area of land and business valuation, including commercial ratings and land tax disputes, and lease disputes. I have more than 15 years' experience in claims associated with the compulsory acquisition of land (together with easements and other rights), including issues associated with residential and commercial premises, agricultural land, development sites and complex commercial economic loss claims. Whilst I act principally for government and statutory authorities, I have balanced that with experience in acting for claimants. I have had particular success in resolving claims in a timely and efficient manner, minimising unrecoverable legal costs. I also advise determining valuers in rent review disputes, and advise and appear generally in matters involving commercial and domestic property and rights, including easements and restrictive covenants.

In addition, I also regularly appear in and advise on matters involving professional liability, regulation and discipline, particularly in relation to lawyers. I have acted in a wide range of matters for the Victorian Legal Services Commissioner and Legal Services Board, both at first instance and on appeal. I regularly act for legal practitioners in negligence claims on instructions from the LPLC, and for other insured professionals. I am also a member of the Victorian Legal Admissions Committee and Bar Ethics Committee.

Although usually briefed to appear and advise in complex claims without a leader, I have considerable experience as a junior to a number of the Victorian Bar's most experienced silks.

Prior to coming to the Bar in 2001, I was a Senior Associate in the commercial litigation group of Clayton Utz.

In 2018, I was appointed a sessional member of the Commonwealth Administrative Appeals Tribunal.
