- appeared in several Royal Commissions, including the Cole Royal Commission into the Building and Construction Commission (as Counsel Assisting), the Royal Commission into Institutional Child Sex Abuse (lead counsel for the Salvation Army Southern Territory) and the Hayne Royal Commission into Financial Services (lead counsel for the Australian and New Zealand Banking Group);
