*Re Good Home & Property Pty Ltd (in liquidation)* [2023] VSC 57 – Application by creditor to remove liquidator pursuant to s 90-15 of the *Insolvency Practice Schedule (Corporations)* (Schedule 2 of the *Corporations Act 2001* (Cth)) and that the costs of the proceeding be borne by the liquidator personally.

*King Kong Corporation Pty Ltd v Moses* [2022] FCA 1066 – Application for urgent interlocutory relief based on former employee’s breaches of restraint clauses and obligations of confidence.
