Eleanor is also a member of the international Society of Trust and Estate Practitioners ("STEP").Eleanor has a Bachelor of Science (Pharmacology) and Bachelor of Laws (Hons). Eleanor has been named on the Doyle's Guide Leading Wills & Estates Litigation Barristers annually since 2015.

Glen first signed the Bar Roll in 2001, and practices in commercial and workplace relations disputes, and mediation, including employment law, industrial relations, franchising disputes, commercial contract disputes, and property disputes.
