For his work in the Solomon Islands representing the Environment Defenders Office NSW making the first ever challenge to a bauxite mine.

# Ron Merkel QC Award

For pro bono work undertaken by barristers who are more than 15 years' call or silks.

For his work representing the family of Maria James (who is the subject of an ABC podcast called "Trace") in applying for the inquest into her death (more than 30 years ago) to be re-opened.

# Public Interest/ Justice Innovation Award

For pro bono work which has a strong public interest element or has involved a procedural or substantive innovation in the law likely to enhance access to justice

#### Hadi Mazloum and Joanna Davidson

For their work in the matter of EHT18 v Melbourne IVF. Joanna and Hadi acted pro bono for the Applicant who was seeking to access IVF having recently separated from her husband (but had not yet divorced him). The Respondent refused her request on the basis that the Assisted Reproductive Treatment Act 2008 (Vic) required her to obtain the consent of her partner, which the Respondent interpreted to including her estranged husband. Joanne and Hadi successfully challenged the provision in the Assisted Reproductive Treatment Act 2008 (Vic) on the basis that it was inconsistent with the Sex Discrimination Act 1984 (Cth) and was therefore invalid to the extent of the inconsistency with s 109 of the Constitution.

## Matthew Meng, Angela Lee and Jennifer Batrouney QC

For their work acting for the Rotary Club of Melbourne in an appeal from VCAT to the Supreme Court. VCAT held that the RCM was liable for stamp duty because, although all the activities undertaken by the RCM are charitable, one of its objects was the promotion of ethics in business which is not charitable. Matthew, Angela and Jennifer convinced the Supreme Court to hear the appeal "on the papers" to minimise the costs risk to their client (in the event that the appeal was unsuccessful).

## Christopher Winneke QC and Karina Popova

For their work representing the family of Maria James (who is the subject of an ABC podcast called "Trace") in applying for the inquest into her death (more than 30 years ago) to be reopened. Chris and Karina's work led to Parliament changing the law so that findings made in inquests under the old Coroner's Court Act could be set aside and inquests/investigations re-opened.

### Fiona McLeod SC / Law Council of Australia

For the LCA's Justice Project (imagined, overseen and led by Fiona McLeod SC). The project is the most comprehensive national review into the state of access to justice in Australia in the past 40 years.

# Felicity Gerry QC and Julia Kretzenbacher

For their work with the Indigenous Justice & Exoneration Project (IJEP), representing a young indigenous man serving a life sentence for murder pursuant to mandatory sentencing laws, notwithstanding that the sentencing judge had accepted that he had withdrawn from the plot and was not present at the time of the murder.

Counsel team for the Barwon Youth Detention matter (Brian Walters AM QC, Peter Morrissey SC, Dr Ian Freckelton QC, Matthew Albert, Sarala Fitzgerald, Dr Adam McBeth, Claire Harris QC)

For their work, instructed by the Human Rights Law Centre, on behalf of a number of detained children, concerning a challenge to the decision of the Victorian Government to gazette part of the maximum security Barwon Prison as a youth justice centre and to transfer children there.

# Sarah Porritt

For her ongoing assistance throughout 2018 in the case of Western Region Environment Centre Inc v EPA [2018] VCAT 154.

We have a long history of giving legal assistance to people in need. It is one of the defining characteristics of our Bar. Our Pro Bono Scheme was established in 2000 to formalise the process and further the reach and access to the pro bono work carried out by our barristers. The Pro Bono Awards were established on the tenth anniversary of the commencement of the scheme to recognise and celebrate the significant pro bono contribution made by members of the Bar.

What sort of work do they do?

The Victorian Bar Pro Bono Committee, together with Justice Connect, oversees the pro bono assistance provided to both individuals and community groups. This work includes advocating for human rights, environmental or social justice causes, and helping people from marginalised and disadvantaged backgrounds.

Pro Bono cases conducted at the Victorian Bar include complex long-running cases on such topics as Native Title, Refugees' Rights, Climate Change and Environment, Animal Welfare and Sexual Discrimination. They can often involve up to several months of a barrister's time.

From people fighting extradition to everyday cases defending people charged with minor summary matters and infringeable offences, the Victorian Bar's barristers have stepped up to ensure that all individuals have access to legal representation regardless of age, gender, race, disability or socio economic hardship.
